

ROWING SOLUTIONS LTD, LIMITED TEN-YEAR WARRANTY

Limited Ten-Year Structural Hull Warranty for Original Owner:

Any structural defect in material or workmanship of the Hulls that is reported during the period of ownership by the original retail owner of the RowingSolutions Ltd catamaran will be repaired or replaced at RowingSolutions Ltd's sole discretion.

The 'Hull' shall mean the hulls of the RowingSolutions Ltd catamaran itself.

A Structural Hull Defect shall mean a substantial defect in the Hull, which causes the catamaran to be unfit or unsafe for general use as a coaching, umpiring or rescue catamaran in normal operating conditions.

What is not covered:

This limited ten-year warranty does not apply to any RowingSolutions Ltd catamaran which has been salvaged or declared a total loss or constructive total loss for any reason not covered in this limited warranty.

This warranty does not apply to the following items:

1. Equipment or accessories which are not installed by RowingSolutions Ltd or which carry their own individual warranties.
2. Cosmetic or deterioration of surfaces including rust, air voids, discolouration, fading or oxidation of surfaces, vinyl, plastics or rubbers.
3. Any RowingSolutions Ltd catamaran which has been sold by a party other than an authorised RowingSolutions Ltd Dealer.
4. Any RowingSolutions Ltd catamaran, which has been subject to misuse, negligence or an accident.
5. Any RowingSolutions Ltd catamaran which has been used for commercial purpose.
6. Any RowingSolutions Ltd catamaran, which has been overloaded according to the maximum load specification on the statutory plate provided on each RowingSolutions Ltd catamaran.
7. Any failure or defect arising from a previous repair made by a non-authorised service provider, unless RowingSolutions Ltd pre-approved the repair.
8. Any defect caused by failure of the customer to provide reasonable care and maintenance.
9. Any item exceeding the expressed coverage limits specified in any RowingSolutions Ltd limited warranty.
10. RowingSolutions Ltd will not be held liable for any consequential loss.

The DEALER who supplies the first owner shall register the first owner's ownership within 14 days of purchase.

No distributor, dealer, agent or other person dealing with RowingSolutions Ltd's goods has any authority to extend or alter these terms and conditions nor to accept liability in respect of the condition of such goods or their fitness for any particular purpose.

The obligation of RowingSolutions Ltd, under this warranty shall be limited to the repair or replacement of parts only judged defective by RowingSolutions Ltd and does not include transportation, or other expenses incurred in returning the RowingSolutions Ltd catamaran to our factory.
